I, Asit Kumar Labh, Practising Company Secretary (ACS – 32891 / CP - 14664) was appointed as the scrutinizer in connection with the 2nd Extra-Ordinary General Meeting ("EGM") of the members of "Manaksia Coated Metals & Industries Limited" ("Company") held on Tuesday, the 19th day of September, 2023 at 01:00 P.M. 

- 1. The remote e-voting period remained open from 09:00 A.M. IST on Friday, the 15th day of September, 2023 up to 5:00 P.M. IST on Monday, the 18th day of September, 2023.
- 2. The shareholders holding shares as on the "cut off" date, i.e. the 12th day of September, 2023 were entitled to vote on the proposed 3 (Three) resolutions as mentioned in the Notice of the EGM dated the 24th day of August, 2023.
- 3. The Company had also provided e-voting facility at the EGM to enable the shareholders attending the EGM through VC / OAVM to cast the votes in case the same had not been cast by them through remote e-voting.
- 4. The votes were unblocked on Tuesday, the 19th day of September, 2023 around 01:55 P.M.
